LFI's – ala carte

- Terrazzo main corridors per building
- Metal roof per building
- 5,000 sf 2nd gym at Elem.
- 2,000sf larger gym
- Reno Central office (allowance)

- Larger windows (allowance per bldg.)
- 6,000sf bus garage
- Additional sf area @ 250/sf

Other LFI's – scope dependent

- Move Middle School walls

 - Range from \$500,000 \$1,000,000+
- Wider hallways (\$250 per sf added)
- High School furniture
- Update Tech Lab
- Larger playground (\$50,000 \$150,000+)
- Purchase property
- Phased construction (% inflation per year)

- \$ 0.30 million

TOTAL \$36.81 million Estimated Local Share at 58% \$21.35 million

Master Plan Option E



New Elementary only:

OFCC project cost variables

Important to Remember

These items will continue to change until the date when OFCC funds the project:

Enrollment – new projection when project is funded
 Equity # (state/local %) – adjusted every September
 Construction cost \$/sf – adjusted every April








Do you think the community would support a new K-5 Elementary School?




Do you think the community would support a new Middle School?


Do you think the community would support a renovated Middle School?



Do you think the community would support roof repair/replacement work at the High School?




Do you think the community would support technology upgrades at the High School?



Do you think the community would support HVAC upgrades at the High School?















How will the community support Option A






